
**unit AL** (2'-5" x 3'-10 1/4")




**unit B** (2'-5" x 4'-10 1/4")




**unit C** (1'-3" x 3'-10 1/4")

# **CONDITIONS OF SALE**

We are pleased to quote the following custom windows and doors from European Architectural Supply.

# 1. The items quoted include the following:

- 1.1 Residential PVC (vinyl) windows/doors manufactured using the German-made SCHUCO technology.
- 1.2 All glass surfaces are quoted as supper-insulated triple pane argon glass with the **Ug value = 0.10**, unless noted otherwise.
- 1.3 Units requiring "safety glass" are quoted using a combination of tempered glass with argon fill, unless noted otherwise.
- 1.4 All muntins are quoted as a simulated-divided lites, except for structural mullions which are true-divided.
- 1.5 The windows can be installed with a variety of sills including stone, brick, cast stone, extruded aluminum, EIFS Stucco. Custom sills are available. This quotation assumes a customer-provided sill.
- 1.6 All window units include a concealed double gasket against water and air infiltration.
- 1.7 All tilt-turn units include multiple-point perimeter locking hardware manufactured of corrosion-resistant steel.
- 1.8 All windows and patio doors include handles, available in 5 designer finishes. Custom handles are available through Rocky Mountain Hardware. Entry doors are shipped with mortised locks. Handles and trim are available from a wide variety of US and European manufacturers.
- 1.9 The quotation includes US customs duties and customs processing fees.

# 2. Transportation and Delivery

- 2.1 All windows and doors are packed at the manufacturing plant and generally remain undisturbed until the unloading.
- 2.2 Our shipments are insured to the location of unloading. In case of in-transit damage, EAS will provide (a) on-site repair if possible/acceptable or (b) accelerated manufacturing of a replacement unit shipped by Air-cargo (size permitting). We are currently operating at a 0% damage track record.
- 3. Installation
  - 3.1 The quotation does not include installation unless specifically quoted.

# 4. The quotation does not include:

- 4.1 Sales Tax.
- 4.2 Sills, interior or exterior trim unless specifically quoted.
- 4.3 Installation, cleaning, caulking, flashing or other type of waterproofing unless specifically quoted.
- 4.4 Insurance or protection during and after unloading.
- 4.5 Machinery or scaffolding necessary to unload and place the units.

# 4.6 Jamb extensions unless specifically quoted.

#### 5. Warranty

- 5.1 Warranty Type and Period: Five years limited warranty from date of installation.
- 5.2 EAS agrees to repair or replace windows and doors that fail due to material or workmanship within the specified warranty period. The failures include :
  - a.) Mechanical or structural failures.
  - b.) Insulation glass failures.
  - c.) Water leakage, air infiltration or condensation on triple-pane units. Under coastal applications or gutterless designs, conditions exist regarding minimal overhang requirements and water-runoff.
  - d.) Defective hardware or failure to properly operate sash hardware. Limited warranty available for sash units over 8 feet tall.
  - e.) Deterioration of metal components beyond normal wear.
- 5.3 Detailed warranty certificate will be provided with details of the Limited Five Year Warranty including conditions, limitations, claim procedures and repair/replacement conditions.

#### 6. Lead Time

- 6.1 **12 weeks** following a 50% deposit and approval of specification.
- 6.2 Please note that lead-times change due to production volumes. The estimated lead-time estimate is valid for 30 days.

# 7. Quotation

7.1 All prices are in US Dollars. Due to currency fluctuations the quotation is valid for a period of 30 days.

# ACCEPTANCE OF PROPOSAL

The above prices, specifications and conditions are satisfactory and are hereby accepted. You are authorized to manufacture the goods following a 50% deposit and the approval of shop drawings. The balance is due one day prior to day of delivery.
