



**GENERAL FLOOR PLAN NOTES:**

1. STAIR MANUFACTURER TO VERIFY QUANTITY OF RISERS AND TREADS (PROVIDE ARCHITECT WITH SHOP DRAWINGS). ALL STAIR DESIGN SHALL BE CODE COMPLIANT, INCLUDING GUARDRAIL.
2. ALL BUILDING MATERIALS USED BELOW THE DESIGN FLOOD ELEVATION (DFE) SHALL BE FLOOD RESISTANT MATERIALS. REFER TO FEMA TECHNICAL BULLETIN 2-2008 FOR ACCEPTABLE MATERIALS. TECHNICAL BULLETIN AVAILABLE AT FEMA WEBSITE.
3. ALL WINDOWS, DOORS AND TRIMMED OPENINGS (T.O.) ON THIS FLOOR TO ALIGN UNLESS OTHERWISE NOTED.
4. G.C. TO REVIEW LOCATION OF H.V.A.C. DUCTWORK WITH OWNER PRIOR TO INSTALLATION.
5. ALL DOOR SWINGS TO BE REVIEWED WITH OWNER PRIOR TO PLACING ORDER.
6. ALL WINDOW AND DOOR SELECTIONS TO BE REVIEWED WITH G.C. AND OWNER.
7. REFER TO KSI DRAWINGS FOR SPECIFIC STRUCTURAL INFORMATION.

**INSULATION & FIRE RATING NOTES:**

1. SPRAYED OPEN & CLOSED CELL POLYURETHANE FOAM TO MEET OR EXCEED: R-30 INSULATION FOR ROOFS AND FLOORS, R-19 INSULATION FOR 2"x6" WALLS AND R-15 INSULATION FOR 2"x4" WALLS.
2. OPEN CELL SPRAY FOAM TO BE USED ONLY ABOVE THE D.F.E. USE CLOSED CELL SPRAY FOAM FOR ALL APPLICATIONS BELOW D.F.E.

3. "PERMACAST" COLUMNS (SEE SIZES IN FLOOR PLAN) BY HB&G WITH FIBERGLASS REINF. POLYMER SHAFT AND TUSCAN CAP AND BASE (TYP.)
4. FRESH AIR INTAKE INTO THE HOUSE SHOULD BE SUPPLIED THROUGH MECHANICAL SYSTEM.
